2. FISLY President's report 2017- 2018

In 2017 championships have taken place on 3 locations with success.

There was a good FISLY council meeting at Düsseldorf.

Lots of work has been done.

The rules project is ongoing with a good result.

The Asnelles project is an opportunity for FISLY to become observer member of GAISF and to develop further landsailing as a sport. Through 'The Alliance of Independent recognised Members of Sport (AIMS)' linked to GAISF we can improve our organisation, attract new members, and go the way to (Olympic) recognition.

On short term the contract with GAISF will have to be signed and the payment to be done.

A lot of work will have to be done in the time to come. Many should engage in the future developments.

Classes : during the last year there haven't been important changes in class rules.

Windpointage has developed for scoring all classes and MY's. Tests have been done to make scoring with transponders.

The president has been to the Blokart Championship in Barcelona. Many countries are interested in becoming member of FISLY. It is good for the future of landsailing. A lot of work is to be done.

Alan is not standing for president for this election for personal reasons and as he had the intention to do only one term as president.

He thanks everyone for the support he has had and remains on board of FISLY.

3. FISLY Treasurer's report 2017- 2018

Accounts 2017

The report is presented to the meeting as well as the budget for 2018.

At this moment there is 20720 € on the accounts.

Important for this year is the introduction of the FISLY international ID. All pilots of this world championship has made his FISLY ID. The payments go over PayPal.

The FISLY ID is not only for Championships. It is a prove of insurance and approval by a federation.

Pilots presenting themselves at an international race in another country than his own can be checked if they have an international ID.

France has paid today the debt of not payment of the FISLY fee at the championship in Leucate.

France has also paid the full membership fee of 480 € in the beginning of the year.

The treasurer's report is approved unanimously by the FISLY GA.

8. GAISF – Observer Membership

Every year GAISF gets about 200 membership applications. 9 have been accepted in the last 2 years. So if our application has been accepted it is a unique opportunity for FISLY. We have to go on or we will not get another chance.

Up to now all reactions in preceding meetings have been in favor of the Olympic project and the opportunities it creates for the development of FISLY and landsailing.

Important also is that we are not in rivalry with another GAISF member.

The condition has been that the Asnelles project engages to pay the costs of membership. They have done up to now.

François Garnavault explains on behalf of the Asnelles project :

The project started as PARIS is in 2024 the Olympic host. He has been in contact with the president of the French Olympic committee. He proposed to start an Olympic project.

In France there are 5 projects presenting.

The project of Asnelles is the only in the West of France, it is on an historically important location, landsailing can attract young people.

There are chances for success.

But FISLY has to be member of GAISF and must make an evolution to a recognition by the IOC.

There are a number of classes that are quite monotype such as Standart, Blokart and Manta.

In preparation of the project a Eurocup will take place at Asnelles on 9 and 10 of June 2019 where per country 4 men and 3 women will be welcomed to sail a new proposed yacht in new racing formulas.

In 2020 another Eurocup will take place. It will also in that year that the decision will be made to accept the Asnelles project in the project fort Paris 2024.

Comment : this project will involve a lot of work. Help will be necessary by all members.

Mr. Greame states it is very important to make the right decisions in favor of our sport.

Floor Lagerwey reads a text with comments for this Olympic project, see attachment.

Financially:

4000 CHF has been paid for the application.

Over two years 16000 CHF of fees will have to be paid.

So this is a commitment of 20000 CHF on behalf of FISLY towards GAISF.

FISLY will prepare a document to make sure that Asnelles will engage to make the payments towards FISLY so that FISLY can do the expenses for this project.

In two years FISLY has to decide and is free to decide if it goes on or not with the GAISF observer membership and/or an Olympic membership without any condition by the Asnelles project.

The GAISF_18.07.26_Land Sailing_FISLY_Acknowledgement & Duties Form has to be signed and sent before the 31st of October. A payment of 4000 CHF has to be done also before the same date.

Voting:

Most of the members present vote in favor of the continuation of the application to GAISF observer membership.

1. Vote on the subject to confirm the observer status as proposed by GAISF by signing the acknowledgement under the condition that JO 2024 Asnelles accepts all financial liabilities arising from this.

—> no from Belgium and no from Germany (6 votes) —> discussion

2. New vote on the same subject but with the condition that the financial liability of JO 2024 Asnelles is fixed in a contract before signing the GAISF acknowledgement.

—> Germany ok, Belgium not ok - Belgium ok after having seen and checked the contract by BFLYC, ACVB and WWSV.

9. ISRR

Approval of proposal from the FCM at Düsseldorf, 3.2.2018 :

'MY:

There is a proposal for the **sail pocket** to have a similar rule as for PROMO and for class 5 :
The external circumference of the mast pocket must not exceed 0,24 m (or 0,12 m long when laid flat, measured on the stitching of the pocket) The stitching of the pocket must close the pocket over its total length (so that the battens cannot pass into the pocket)
The rules seminar is asked to work out a rule to vote on.'

Actual rule :

APPENDIX n. 2 G MINI YACHT SPECIFICATIONS 5.60 :

7. The sail must be free to rotate around the mast with a mast pocket that is constructed of sail cloth without any stiffener, shape former or support.

Proposal text to be added:

The external circumference of the mast pocket must not exceed 0,24 m (or 0,12 m long when laid flat, measured on the stitching of the pocket) The stitching of the pocket must close the pocket over its total length (so that the battens cannot pass into the pocket)
The sail must be free to rotate around the mast
Stiffeners, fairings or similar devices fitted inside or outside the mast pocket are prohibited.

Fairings or similar devices fitted onto the sail are prohibited

Denmark :

Next year the club in RØMØ proposes to organise the European Championships in the week from the 23rd to the 30th of June.

The FISLY GA agrees on this proposal.

Class 2 association:

There is a proposal to think about a future evolution so that the big yachts (2 and 3) could sail in one class.

Having one 3 classes : big ones, a medium class and small yachts class could be more workable for organising events.
